## COVID-19 Guidance on In-Person Meetings and Events on LACOE Campuses for Students, Staff and Visitors

This guidance applies to all individuals, including but not limited to employees, students, contractors, and visitors.

## Vaccinations/Masks/Daily COVID-19 Screening Survey

- Irrespective of vaccination status, it is strongly recommended that attendees **wear a high-grade or surgical mask when indoors.**
- Attendees at indoor events who are not LACOE employees must show proof of:
  - Being fully vaccinated, or
  - A negative COVID-19 test. The test must have been conducted in the last 1 day for an antigen test, or 2 days for a PCR test.

(Note that LACOE employees meet the above requirement as part of their employment at LACOE).

Note <u>Vaccine Record Verification Guidelines</u> may be used to verify vaccination status; in such instance, self-attestation will not be accepted.

Visitors aged 18 and older may be required to provide identification that confirms that they are the person presenting proof of COVID vaccination or negative test result before entering an indoor event/meeting venue.

 All attendees at indoor meetings/events must take the Daily COVID-19 Screening Survey provided by LACOE online (available via Staff Portal, daily emails and QR Codes at the receptionist's desk).
